Competitors have hailed from Connecticut, Indiana, Illinois, Kentucky, Louisiana, Massachusetts, Michigan, Minnesota, New York, Pennsylvania, West Virginia, Canada, and of course Ohio.

Over the last twenty five years, Stone Gate Farm has hosted numerous competitions including the USEA Area VIII Championships and Tri-State Regional Pony Club Rallies. Stone Gate Farm is also home base for the Western Reserve Pony Club.

Stone Gate Farm has hosted clinics for the USEA Area VIII Adult and Young Rider programs. These clinics are taught by the coaches of the respective teams that will represent Area VIII in the USEA Adult Team Championships and the North American Junior and Young Rider Championships. In addition SGF has sponsored USEA Instructor Certification Program Workshops and Assessments. World renowned event rider and clinician Lucinda Green from England will again be heading the list of clinicians. A **new** ‘event’ camp has been added for 2011 with nationally recognized USEA Certified Instructors Sue Hines, Eric Dierks and Doug Payne.

In addition to the events, clinics, and Pony Club activities, Stone Gate Farm also hosts Hunter Paces in the spring and the fall. These are much more relaxed competitions that draw numerous enthusiastic riders of all ages and abilities and include many riders who don’t attend the other competitions.

In a year’s time more than 800 riders, family members, friends and support staff come to Stone Gate Farm for one activity or another. If you include visits to the website, Facebook and the blogs that number goes up dramatically (*see the SGF Traffic Facts*).
